Using your Consultation Coupons - The coupons are valid for one year. These coupons are for consultation purposes only. They're designed to offer you the opportunity to meet and interview an attorney who may be representing you prior to any commitments. Often these are used to determine compatibility, examine qualifications or discuss strategy. Others use them as an opportunity to see the environment and staffing of the attorney's office, or to meet the attorney and his or her aides or paralegals. There are several services the coupons cannot be used for, so please read your coupons carefully.

Legal Security Package - You are entitled to one Legal Security Package each plan year. This package contains forms required to produce your Simple Will, Health Care Proxy, Living Will and Durable Power of Attorney. Download this package at

www.memberbenefits.nysut.org; use the Legal navigation tab on the left-hand side. If you don't have Internet access, call the Administrator, Member Benefits, at (800) 626-8101. Complete the package and send it to the National Legal Office. Four to six weeks following the National Legal Office's receipt of your Legal Security Package, your legal documents will be forwarded to you along with the name, address and telephone number of a participating attorney in your geographical area who will supervise the execution of your documents at no cost. Instructions for ordering additional packages for other Covered Dependents are in your package.

Note to Payroll Deduction Participants - Your Plan expiration date is August 31. Renewal is automatic. Prior to September 1 of each year, you will receive your renewal ID card and coupons. Your payroll deduction for this plan shall remain in effect until revoked by your written authorization, submitted to: NYSUT Member Benefits Trust, Legal Service Plan, 800 Troy-Schenectady Road, Latham, New York, 12110-2455.

Note to Elder Law Rider Participants - If you've purchased the optional Elder Law Rider, you're entitled to an additional Legal Security Package and a 20 percent discount off Elder Law attorney fees. Benefits under this rider are extended to parents (and in-laws) and grandparents (and in-laws). Refer to your Certificate for details on these benefits.
